Position Title : Landscape Technician – MEP

Department : Technical Services

Scope of work (JOB PURPOSE)

Reporting to the **MEP Manager**, you are to assist the facility Shifts that operate within the facility maintenance department. You are responsible for a number of tasks, such as digging and raking the soil, weeding and mulching the area, fertilizing the land and growing new flowers and plants, trimming hedges and cutting branches, and mowing lawns and maintenance of the irrigation system. Besides ensuring the attractiveness of the landscape, you must also keep the area free of diseases and insects.

You must be creative, have excellent problem-solving skills and organizational abilities to ensure the growth of plants and maintaining the landscape design.

Main Responsibilities

- · Maintaining inventory of landscaping materials such as mulch, fertilizer, and pesticides
- Planting trees, shrubs, and other plants
- Mowing lawns, trimming hedges, pruning trees, remove weeds and dead plants and performing other maintenance activities
- Installing irrigation systems and sprinkler heads to ensure that plants have adequate water supply throughout the growing season
- Evaluating soil and other conditions to determine what types of plants will thrive in a particular environment
- Assisting your supervisor for Selecting and ordering plants
- Diagnosing and treating plant diseases or insect infestations with chemical or organic solutions
- Installing topsoil, mulch, and other materials on newly developed lots to ensure that plants have adequate support and nutrients
- Conduct general maintenance duties such as cleaning walkways and removing dry leaves
- To assist the Facility management team to maximizing ride and equipment availability and safety in operation.
- To ensure that you complete PPM'S in a timely manner in line with department procedures.
- To assist other departments as and when required to support the operation of the park.
- To respond to unplanned maintenance, planned preventative maintenance, MEP start up procedures and safety checks when required.

Health & Safety

Qualifications, Experience, & Skills

Required Qualifications:

- High school diploma or equivalent qualification. At least 3 years' experience of working as a Professional Landscaping and irrigation technician in ideally an MEP environment.
- Working knowledge of the DM and DCD requirements
- A full working knowledge of appropriate engineering related statutory requirements e.g. certification and safe use of lifting equipment, C.O.S.H.H., safe use and written schemes of pressure vessels, general responsibilities for the maintenance of a Safe Working Environment under the Health & Safety at Work Act etc.

Job Specific Skills:

- Must be able to operate maintenance equipment including lawnmowers, leaf blowers, hedge trimmers, weed trimmers, and chemical spray.
- Strong knowledge of pest management, Fertilizers, and basic Irrigation system and lawn maintenance.
- High attention to detail when performing lawn maintenance or designing gardens.
